In states like Tamil Nadu, Jharkhand, Maharashtra and West Bengal we have begun developing State plans for VISION 2020 initiatives.

Thanks to the support of member organizations (particularly INGOs for their contribution as a consortium and NGOs for spontaneous collaborations to organize these programs), we have done well in capacity building programs among stakeholders- be it Resource Mobilization, Low Vision services, Diabetic Retinopathy or Refractive Error.

At the Advocacy level, we have been working hard for the spread and coverage of the essence of the movement nationally. The joint celebration of World Sight Day 2005 with Government of India and INGOs at Hyderabad, VISION 2020 orientation in Central India in Chitrakoot for the renewed commitment on the part of all stakeholders for the movement are few examples.

Our work in Member Service and networking across the country aims to raise awareness of the needs of the people and rights of people with needless blindness and at the same time, to assist and support with essential services, on site and offsite, to our member organizations. Major focal activities in this area include- information spread, publications, workshops / seminars and capacity building programs involving all categories of Eye Care professionals and practitioners.

We hope that you will support us serving the VISION 2020 movement vibrantly as ever.

HISTORY

From an exemplary group initiative.....

Our Principle: To Follow a culture of Excellence and collaboration with an unwavering commitment to member satisfaction and dynamic movement.

In 2001, a group of National Eye Care agencies had a meeting in Goa to take a resolve to work with Government in Partnership for VISION 2020 Initiatives united. It was the beginning of an increasing awareness to give strategic direction to the efforts to eliminate avoidable blindness under a global initiative in our country.

In 2003, all the international NGOs, National NGOs and Government again met as a final step, this time in Hyderabad in order to continue what they considered as “The Vision 2020: The Right To Sight – India”, initiated in much more structured way and with aspirations spelt out and designed a mission for themselves to fight Avoidable Blindness as a movement. The VISION of the Visionaries now lives in VISION 2020: The Right to Sight – India that operates across the country.

VISION 2020: The Right to Sight –India: The Genesis

2003: A Steering Committee was formed to develop legal and structured organization for spearheading the movement in the country.

2004: VISION 2020: The Right to Sight – India was legally founded as an autonomous Confederation of NGOs / INGOs with the Government, WHO and IAPB as special invitees (May 26, 2004).

VISION 2020 India (now based in New Delhi) was founded 2 years ago (May 26 2004) as a Confederation of INGOs and NGOs for the movement against Avoidable Blindness and has since become one of India’s most important advocacy and action organization in eye care, thanks to the support of over 46 INGO and NGO members from across the country- the initial three year funding support from the consortium of INGOs and moral support from the Indian Government.

VISION 2020 is greater than the sum of its parts. This acts as a force multiplier that gives each member the collective power of all members to speak and act on issues of common concern. VISION 2020 India coordinates with its members so that in unison they can influence policy and debate on issues affecting millions of people across the country and improve their own working practices.

We work with more than 200 Eye Care NGOs in the country providing professional inputs and solidarity- support to be able to serve people with eye diseases.

VISION 2020 India is a non-profit organization, which is committed to universal values of service and solidarity as well as human rights, which helps and supports the people with Avoidable Blindness in the underserved regions of the country.

Reflecting both the concern of Indians and their strong support for the movement against Avoidable Blindness, we receive great contributions from major stakeholders. VISION 2020 India bears highly the responsibility of the trust, the Indian people place in us. As such, members ascribe to VISION 2020's NGO standards that helps assure accountability.

Our work focuses on the following activities:-

- Advocacy for preventing blindness and restoring eyesight.
- Promoting the rights of persons with blindness.
- Strengthen infrastructure suitable for excellent eye care.
- Enhance Human Resources for effective Service Delivery.
- Networking withal Stakeholders in Eye Care.

- To empower member NGOs to help themselves.
- To create sustainable and best practices.
- To build capacities for participation of all.
- To integrate the movement in all spheres of life.

Our long-term commitment at the interface between the elimination of Avoidable Blindness, various stakeholders and development partnerships means that we are obliged to expand our effective contribution and support for people with blindness in the underserved regions of the country. Our work makes a meaningful contribution to eliminating the Avoidable Blindness as a movement and enforcing human rights.

HIGHLIGHTS

It was a very satisfactory year from the point of creating greater awareness if not good “impact” at various levels in the country on VISION 2020 India movement. As per our mandate we have devoted our time, energy and resources very judiciously for both Advocacy and Action that have enhanced not only our partnership process with Eye Care fraternity but also contributed to increase in the Membership base.

More significantly the celebration of World Sight Day 2005 in association with Government of India at Hyderabad was a breakthrough in advocacy. This event was graced by the President of India, two Health Ministers, Information and Broad Casting Minister from the Center, State Health Minister and the presidents of IAPB, LCIF and VISION 2020 India, besides a large number of stakeholders from the Government, INGOs and NGOs .

In a significant initiative by Government of India, it has given us a central position to coordinate the task of coordinating of XIth Five Year Plan for NPCB. Thus, we have been recognized for our strength in terms of number, voice and work at the same time, we have been an integral part of Task Force Committee for this purpose.

We are happy to welcome 13 new member organizations that have joined us this year. We have been able to facilitate development of State Plans and wider network in support of VISION 2020 initiatives in about half a dozen States in the country. We have been able to establish new strategic partnerships with several National and International associations working in Eye Care ranging from Light for the World, Austria to Indian Optometry Association and Deccan Ophthalmic Association, and so on.

Towards the development of capacities of our members and other stakeholders in Eye Care we have conducted 10 Workshops on emerging themes of Eye Care service i.e. Resource Mobilization, Diabetic Retinopathy, Low Vision, Refractive Error, besides actively propagating our mission in various fora and media across the country reaching out directly to about 10,000 audiences.

In the history of VISION 2020 August 2005 was a important month when it had first Annual General Body Meeting with a focus on developing Five Year perspective Plan for the organization and also the strategic decision to shift the National Secretariat to capital of India, New Delhi was taken.

An all round and well-balanced progress was made as described in the following pages.

Program Priorities

1. Advocacy

Approximately 110 million people in India live with disability of Blindness and visual impairment. 70% of them live in rural areas. VISION 2020 India is committed to the task of opening up new prospective on life of people with blindness in the country. In order to provide this service, we have to reach the communities. In its partnerships with NGOs, VISION 2020 India, therefore strives not only to improve the conditions of life but also to promote sustainable development in the locations.

VISION 2020 India undertakes extensive information sharing and generation, capacity building, advocacy and promotion of networking among Eye Care NGOs in its effort to coordinate Eye Care service organizations so that prevention, quality eye care and support services are available to all.

VISION 2020 carries out advocacy action on matters of mutual interest to Eye Care NGOs (working for the people affected by Avoidable Blindness) including policy development, advocating for the rights of people living with blindness and for resource planning and allocation.

2005 was a year of campaigns, where public policy and grassroots mobilization came together nationwide to push national leaders to do more on behalf of the country's visually impaired. VISION 2020 was in the centre of activities through its work with Task Force Committee and World Sight Day Committee

- **National Plan for VISION 2020 India Initiatives.**



In this year Government of India under National Program for Control of Blindness (NPCB) started the process of formulating a comprehensive VISION 2020India – NPCB policy for the country under XI Five Year Plan. This process required consultation from different stakeholders including Eye Care NGOs. As part of its advocacy and mobilizing program, VISION 2020 India Forum, mobilized and brought together all concerned in the

form of Task Force Committee to input to the eye care policy development process in XI Five Year Plan. This was done through formation of Task Force Committee by the Government of India and organizing several consecutive meetings with these organizations where policy issues were discussed and gaps identified. A draft plan outlining priorities, gaps, implementation structure and budgetary allocations and recommendations for Monitoring and Evaluation is under preparation for submission to the Ministry of Health and Family Welfare, Government of India where the Chairman of TFC, Secretary Health is to finalize the process. VISION 2020 India's contribution as the Central Coordinating Agency in this process was commended by the NPCB of Government of India, which is spearheading the movement.

- **WORLD SIGHT DAY 2005**

Sight for Kids was the theme and slogan respectively for World Sight Day 2005. This year campaign was intended to further a sustained focus on Childhood Blindness. VISION 2020 India was actively involved in preparations and organization for World Sight Day 2005 with Government of India and LCIF. VISION 2020 also contributed resources for the day's campaign activities, involving the Honorable President of India, Union and State Health Ministers, and distinguished representatives of IAPB, LCIF and VISION 2020 fraternity. During World Sight Day 2005, Union Health Minister honored the grassroots Eye Care NGOs with a National Award on behalf of VISION 2020 India,



Vision 2020 India organized rallies, TV releases and promotion material (such as T – shirts and posters) for World Sight Day Campaign. World Sight Day 2005 exhibition and signature drive was also organized at Hyderabad on 13 – 14 of October 2005.

2 Capacity Building and sensitization

Key for sustaining prevention and care efforts is to give the grassroots organizations the necessary skills to align, design, manage and evaluate Eye Care Services. Such is the Central purpose of the Capacity Building and Sensitization carried out in the form of workshops and seminars by VISION 2020 India. VISION 2020 builds and strengthens capacity of Eye Care NGOs to carry out effective sustainable programs so as to achieve their goals. In this year, VISION 2020 India strengthened NGOs capacity in Resource Mobilization, Evaluation, Networking Skills, and Advocacy Skills (With the workshops in Hyderabad and Chitrakoot) in Eye Care Services.

In partnership with IAPB, ICEH and other international NGOs, networking and advocacy workshops of VISION 2020 India have been conducted for members to gain an understanding of the concepts and their applicability in movement responses. Besides, several subject specific Workshops such as Low Vision in Ahmedabad, Diabetic Retinopathy in Kolkata, Refractive Errors in New Delhi, and Childhood Blindness in Hyderabad were conducted. The objective of the Workshops was two fold: to acquaint members with latest knowledge and practices in the subject and two, to evolve some policy guidelines for all the stake holders including the Govt. of India.



3. Development of State Plans /Networks

In line with the 2005 Annual General Meeting resolution to establish State wise networks of eye care agencies and in an effort to facilitate networking consequently bringing to scale the response to the movement at the grassroots, VISION 2020 embarked on establishing and facilitating State level networks of Eye Care NGOs while working for development of State plans in different states. This year the State Plans facilitated and networks developed are in Rajasthan, Tamil Nadu, Maharashtra, West Bengal and Jharkhand and Andhra Pradesh States.

Support / facilitation visits to States and individual organizations were done in this year. Among the issues for facilitation were developing the State Plans, resolving Grant In Aid issues, formation of state networks, to share up dates on national and international, old and new up coming eye care initiatives and funding opportunities including the implementation of National Plan.

VISION 2020 has been engaged in consultations regarding resource and management for Eye Care NGOs. VISION 2020 this year has enjoyed cordial partnership with and worked closely with NPCB of Government of India and INGOs especially developing guidelines for Grant in Aid and other as regards identification credible partners that could benefit from the program resources.

In this direction VISION 2020 participated in the national process regarding development of Grant in Aid guidelines. VISION 2020 representing Eye Care NGOs in Tamil Nadu has prepared and developed the comprehensive country level organization for Grant in Aid.

4. Information generation and sharing

VISION 2020 has continued with its efforts to uphold comprehensive information among Eye Care NGOs through its MIS. This activity aims to promote information and experience sharing among Eye Care NGOs so as to foster quality service among the community. It has been a challenge however to make the often different and complex information on various topics of eye care services easily accessible and understandable. The VISION 2020India has done and acquired a range of different publications, striving to meet the needs of member organizations and partners who are our resources. We identify, compile and provide easy access to material of various topics related Eye Care.

a) Information Material

CEH Journal: VISION 2020 India Journal, the official quarterly publication is produced with the support of ORBIS International and LV Prasad Eye Institute to keep members

and partners abreast on relevant Eye Care issues. This year VISION 2020 produced 18000 copies of the CEH Journal. Name of the issues:

Monthly E- News Letter: So far in this year we published 12 issues and circulated to about 100 odd strong network and members in the country and also governmental agencies. It goes out ritualistically by end of 2nd week of every month across the nation.

Information from other sources: Many other resourceful documents were acquired from different sources including the Central Government, member organizations and partners. These included Guidelines for Grant in Aid (GIA) for NGOs and DBCS, Dissemination Reports and presentations. The demand for more information from the Secretariat on different Eye Care topics has gone high in this year.

b) Distribution:

The information collected or produced is distributed to member organizations, national and international partners by post, at the secretariat, international, national, inter agency exchange visits, conferences, exhibitions, workshops to mention a few.

The demand and quality of publications has grown in this year and feedback indicates that the information contained therein is pertinent for the readers.

Electronic mailing list of several VISION 2020 Members and partners was developed and continues to be updated. This has facilitated faster communication with members and partners on matters that are beneficial to all.

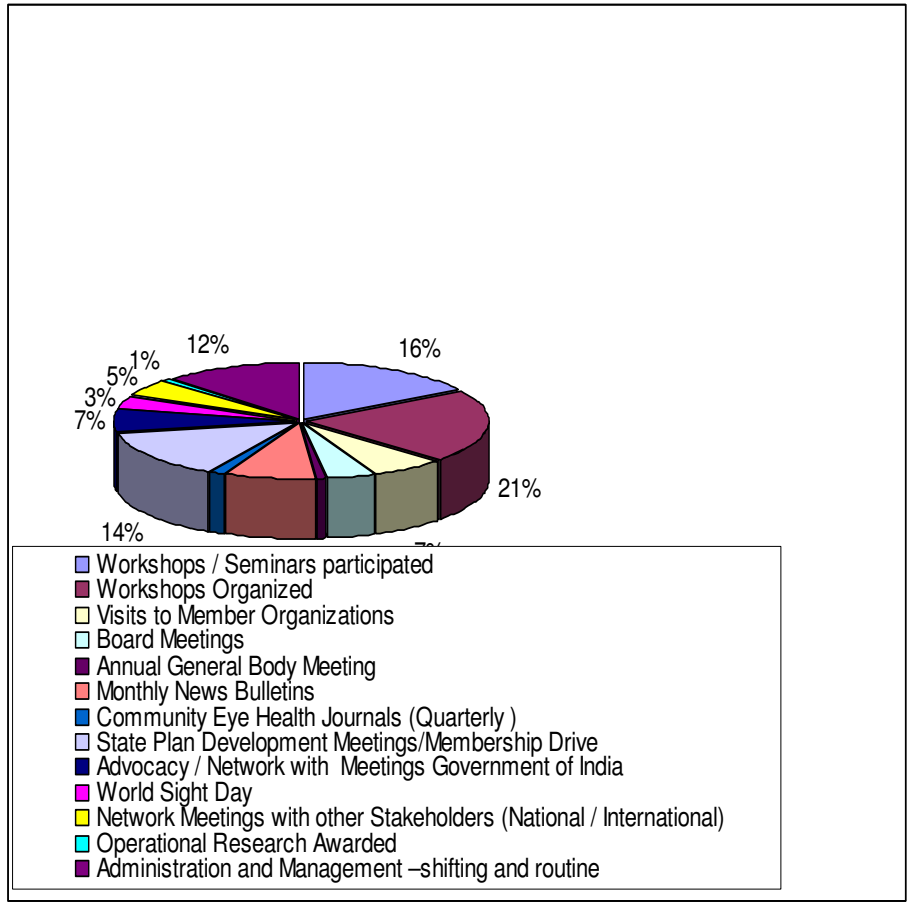
5. Strategic Partnerships developed

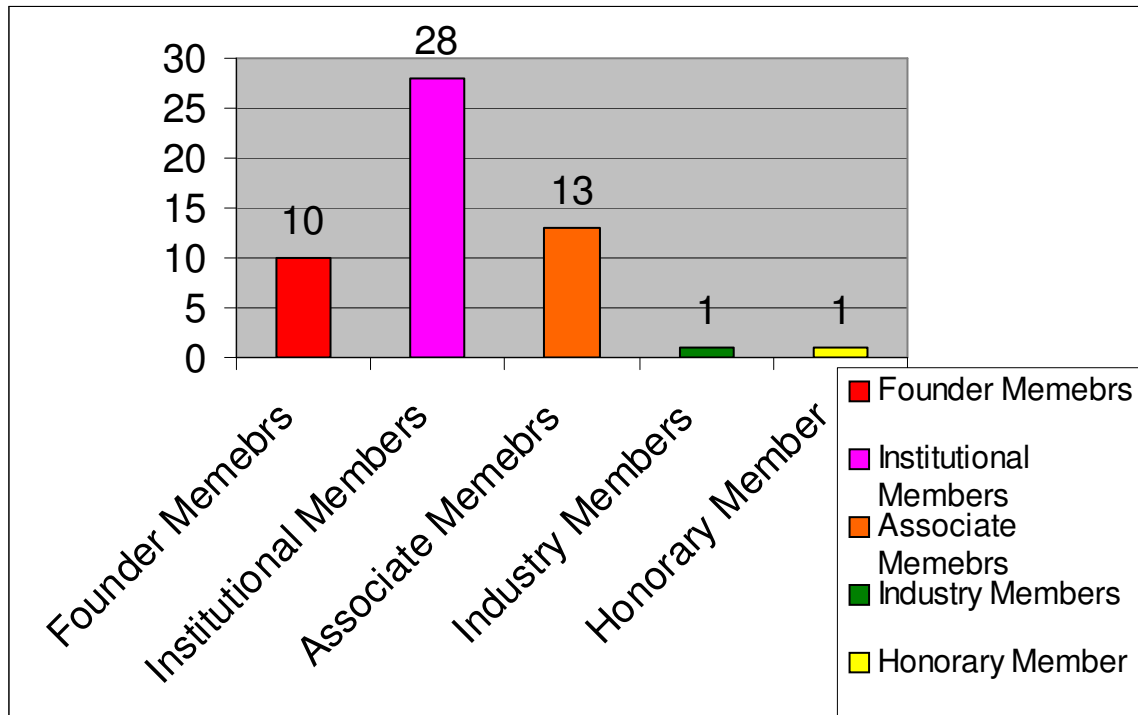

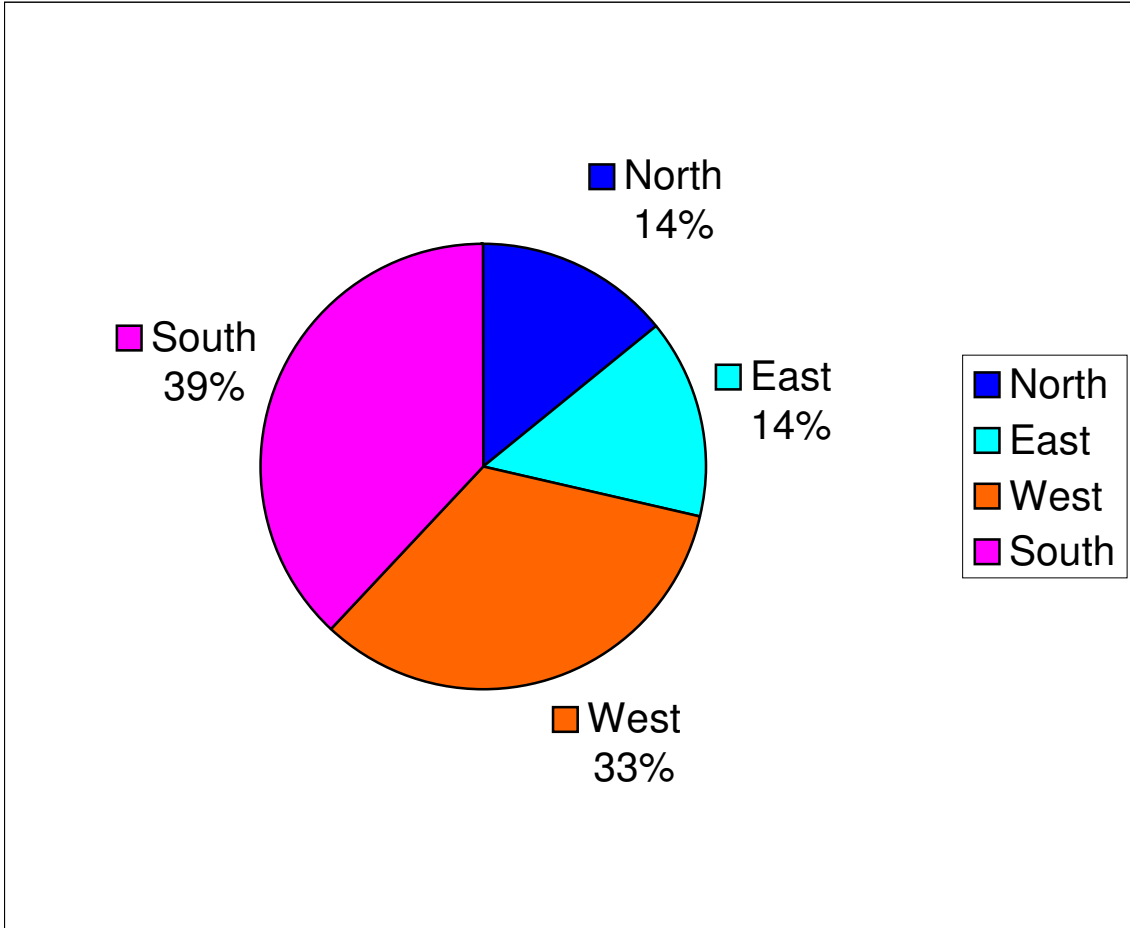

6. *Adherence to process of Institution Building*

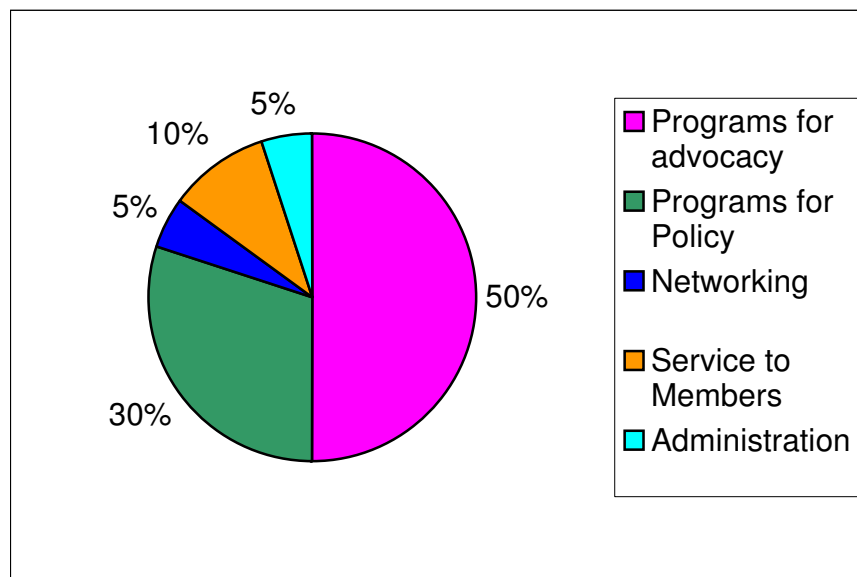
