
## *Annual Report 2006-07*

## About VISION 2020: The Right to Sight - INDIA

**VISION 2020: The Right to Sight - INDIA** is a national coalition of Non-Governmental Organisations (NGOs), Professional Associations, Eye Care Institutions and Corporations and is a part of the Global joint initiative of the World Health Organization (WHO) and the International Agency for the Prevention of Blindness (IAPB) **VISION 2020: The Right to Sight**.

**VISION 2020 INDIA** was conceptualized in India in January 2003 and formally registered as **VISION 2020: The Right to Sight – INDIA**, as part of Global Initiative on May 26<sup>th</sup> 2004 as a confederate under Society's Registration Act in Madurai, Tamil Nadu.

**VISION 2020: The Right to Sight – INDIA** is an independent, collective voice for civil society engaged in eye care. It was established to bring together NGOs working in areas of Advocacy and Lobbying to effectively engage on Eye Care policies, so that they reflect the views and concerns of the millions of needlessly blind. It is a membership Organization that includes Community-Based Organisations, National, Regional and International NGOs, and Networks in eye care.

## **POLICY and PROGRAM DEVELOPMENT**

This is our second strategic priority that we have efficiently and sufficiently pursued during the year.

### ***National Plan – XI Five Year Plan - Historical contribution***

A lot of time, energy and resources have gone into developing XI Five Year Plan as part of Govt. constituted Task Force Committee with us in the first quarter of the year. Brain-storming, drafting and re-drafting, circulations, consultation, presentations at all levels were extensively done before it was submitted to Govt. of India on 12<sup>th</sup> June 2006. The effort did not stop there. We had done excellent follow up to its successful acceptance and support at Health Ministry, Planning Commission and the Finance Ministry. As a result of our collective, responsive and sincere effort, the national Plan has been in principle approved at a sumptuous budget of Rs. 1550 crores, three-fold higher than X Plan. Now that we are through with Planning Process, our next challenge and commitment is its effective execution by restructuring implementation framework under Public – Private – Partnership. If one takes a look at the process below, one would conveniently realize the great work that we have been able to do at the national level.

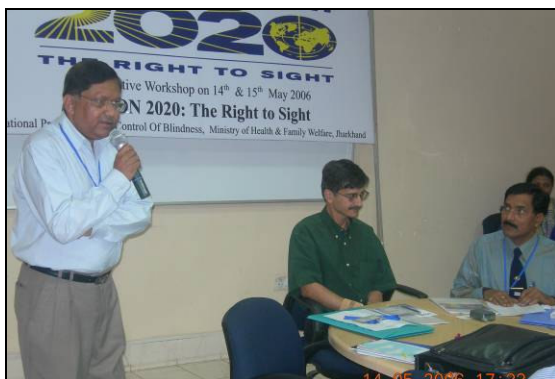

### ***Development of State Plans in alignment with National Plan***

Second important contribution and value addition that we do in the movement is facilitating development and management of State VISION 2020 Plans in alignment with National Plan. This is our core activity that has been systematically pursued. During the year, the state plans of Jharkhand and Tamil Nadu were finalized. States such as Kerala, Maharashtra, and Chhattisgarh have embarked upon constituting Planning Committees to brainstorm and drafting their plans. While AP State consolidates its approved Plan, the ORISSA State has taken initiative to begin its plan process. With the trends available we are optimistic that we will have facilitated the state plans in more than fifty percent of the states of India by 2008.

### **Plan Implementation Guidelines for both Government and NGO sectors**

Another and third most important contribution that we have been able to make is: “To support the Ministry in developing appropriate implementation guidelines utilizing the Interface of GO and NGO functionaries engaged in eye care across the country”. In this direction we had jointly, GOI and VISION 2020INDIA, conducted the most sought after exercise, the first of its kind - Western Region Eye Care Stakeholders Workshop on XI FYP Guidelines (22 – 23 Feb 07) in Udaipur, first one in series. The recommendations have been passed on to GOI for incorporating them for effective action.

## **QUALITY EYE CARE**

Our mandate is to strengthen service delivery. The essential components that immensely contribute to service delivery are Standardization, Accreditation, Uniform Curriculum, Best Practices, Protocols & Procedures and Monitoring & Evaluation particularly in the areas of clinical service as well as HR development. Keeping this in view we have taken up several initiatives such as below during the year. They have substantially helped in internal learning, transmission and sharing. We have done it in three ways – organizing thematic workshops, facilitating and participating in specialized training seminars or CBPs and consultation and collaboration with national institutions like IGNOU.

## **RESOURCE MOBILIZATION and SUSTAINABILITY**

### ***Serve to Succeed***

To make our organization a vibrant, democratic and learning forum, it is absolutely necessary that it has all the autonomy under the sun to perform top. That freedom and flexibility are possible and viable, only when it has strong system of mobilizing its resources internally and to some extent, externally as well. One of the validated methods of resource mobilization we have been following is new membership drive and most importantly strengthening existing memberships through value added services.

Our service portfolio to benefit members is as below:

- **Sharing experiences:** It gives an opportunity for indigenous and International Organizations to meet and share experiences and jointly undertake critical analyses of strategic issues that affect the visually challenged.
- **Capacity building:** It provides opportunities for capacity building especially on topical issues.
- **Use of brand and corporate identity:** The Forum gives an opportunity for affiliated fora to use their certificates and good name of the V2I (with its consent) to further their objectives.
- **Joint advocacy:** It also provides a strong ally in holding Government and global governance institutions accountable for pro-needlessly blind policies and outcomes.
- **Reference point:** The V2I provides a contact point for Government, donors, NGOs and other partners. This facilitates easy access to individual NGOs at the district and other levels.
- **Improved visibility:** It provides an opportunity to contribute to a more effective and visible civil society engaged in eye care policy advocacy.

- **Effective Information exchange:** The V2I also coordinates and processes feedbacks from various fora. It provides linkages between the NGOs at different levels with Government and other development partners. This facilitates information exchange and resources for effective development.
  - **Improved performance and accountability:** The V2I has been a source of constructive criticism and challenge. This leads to improved performance and accountability.
  - **Synergy:** Through the V2I, areas of comparative advantage are identified from various forums and interventions are done.
  - **Effective networking:** The V2I facilitates networking and dialogue among NGOs/CBOs to build consensus on issues critical to policies impacting on Blindness elimination and other development concerns.
  - **On site consultation / counseling:** In the areas of Disease control, HR, Infrastructure, equipment and local networking.
  - **Off site consultation / counseling:** In the areas such as GIA / Funds / Legal matters.

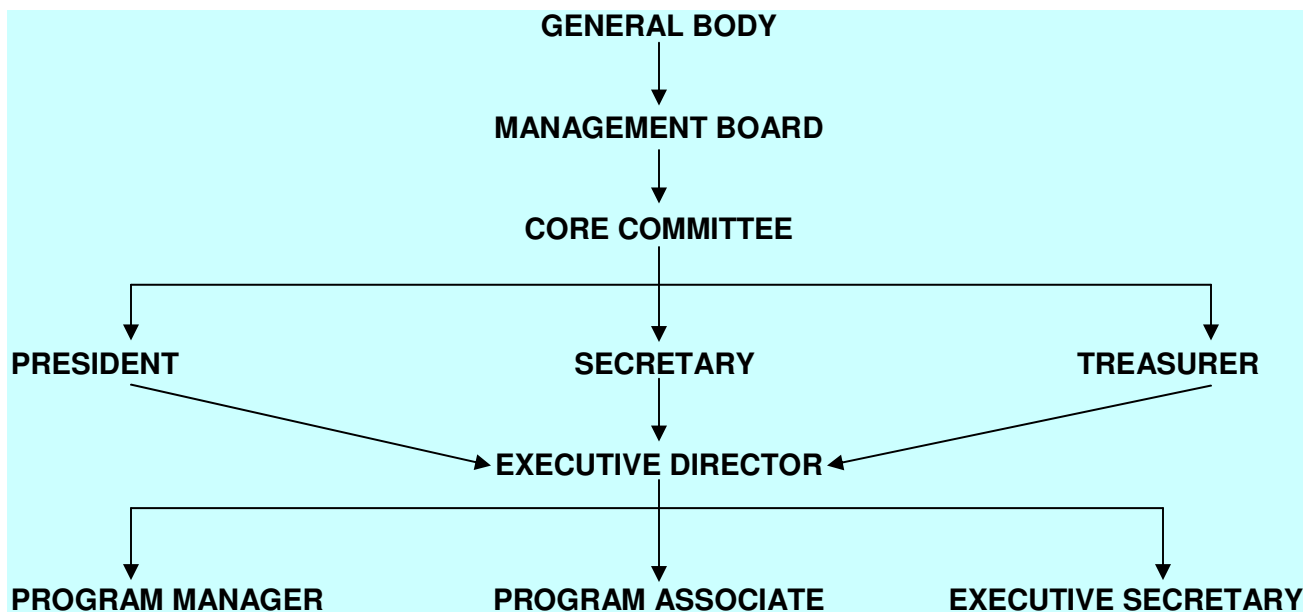
