

VISION 2020: The Right to Sight – INDIA's Initiatives


ne of the most significant initiatives of VISION 2020: The Right to Sight – INDIA in the year 2011 – 12 was developing the VISION 2020 - India's five year action plan. With the year 2020, the year by which VISION 2020: The Right to Sight – INDIA aims to achieve its goal, round the corner, it was time for some introspection and analysing the strategies adopted so far. It was time to ascertain if the path we had traversed so far was the correct course to reach the goal of eliminating avoidable blindness by year 2020 or was there a need for a course correction.

VISION 2020 - INDIA'S Five Year Action Plan

Two important meetings with the INGOs were held – one at Sightsavers office in Mumbai and the other at the H.V. Desai Eye Hospital, Pune. The aim of the meetings was to discuss the following key topics:

- Strategic Plan
- Agreeing to the priorities
- Five year (2012-2016) proposal

After discussion and deliberations on the strategic plan, the meetings yielded the five year action plan 2012 - 16 for VISION 2020: The Right to Sight – INDIA. Three main areas were identified to be the focus for the Five Year Action Plan and an action plan developed for each of these areas:

Activities for the next five years have been developed around the three focus areas:

QUALITY EYE CARE

Towards ensuring that our member hospitals achieve quality in eye care, VISION 2020 – INDIA will map human resource gaps and chart out a plan for developing human resources. To build human

resource capacity, VISION 2020 - INDIA has designed Hospital based clinical and non- clinical skills transfer programs keeping in mind the importance of quality in eye care services. The aim of these programs is to recognize the top providers of eye care services in the country and develop training modules with their help which can be used to train hospitals lacking good human resources. This should also help in building a team based environment in hospitals thus maximizing the potential of the organisation, the benefit of which shall pass on to the patients.

As part of activities to be undertaken, VISION 2020 – INDIA will be advocating for improvement in quality of postgraduate courses and for developing new courses with an aim of increasing the supply of eye health personnel from all cadres.

VISION 2020 – INDIA intends to partner with leading eye care institutes in developing best practices manuals on various topics which would serve as a guide to adhering to quality.

We will also work towards enabling organizations in conducting quality assessments at their institutes so that they can do a thorough review of their systems.

Health Management Information System (HMIS) has being designed and developed by National Programme for Control of Blindness to improve the quality of services being rendered to patients by streamlining processes, reducing costs and improved monitoring.

NPCB has launched the HMIS and it is now live for use by all NGOs. VISION 2020 – INDIA has communicated to all its members regarding the need to use this system and also circulated guidelines which would help the members register on HMIS. VISION 2020 India is also assisting its members in resolving issues faced during registration or use of the HMIS. The feedback sought is being constantly shared with NPCB and efforts are being made to make the process smoother.

EQUITY IN EYE CARE SERVICES

Equity is about the fair distribution of resources throughout a group of people according to population, not individual, need. Equity means not discriminating between people of different ethnicity, religion, age, gender, or social class, and delivering services in an acceptable, accessible, and affordable way.

A lot of disparity in the distribution/ availability of eye care services are prevalent across the country. However, the occurrence of blindness is more prevalent in the underserved population and hence there is a need to ensure equity in provision of eye care services, not just at various income levels but also across geographies, socio-economic status, gender, age, caste, religion etc.

VISION2020 - INDIA is working towards advocating for policies and developing projects that aim at eliminating gender differences in provision of services. As per research, of the total number of people blind in the world today, 64% are female.

To bring about equity in eye care services there are three important steps that VISION2020 – INDIA will be taking:

- Identification of equity related gaps in the services being provided by conducting an analysis in certain selected districts.
- Build capacities of partner organizations developing and implementing pilot projects which can then be replicated at other places.

• Advocating for changes in policies and programs to ensure that the underserved areas, such as N.E. states, are given due consideration.

COMPREHENSIVE EYE CARE

In order to eliminate the causes of avoidable blindness it is imperative to look at eye care and health in a comprehensive manner and address all pertinent issues rather than focus on just the leading cause of avoidable blindness. Comprehensive eye care comprises of three factors –

- *Comprehensive eye examination*, which includes a series of tests and examinations that are to be conducted for every patient in order to ensure that all possibilities of eye problems are evaluated.
- *Comprehensive eye care services,* involves promotion of eye health, prevention, diagnosis and treatment of all relevant eye diseases and rehabilitation services to those with irreversible blindness and low vision.
- *Comprehensive eye care system* aims to provide comprehensive eye care examination and services to everyone in the society without discrimination by gender, age, socioeconomic status etc. For a comprehensive eye care system, it is important to develop infrastructure - physical and human resources and to develop processes for monitoring and evaluating performances and conduct targeted operational research.

VISION 2020 – INDIA will work towards developing all three abovementioned factors through its member hospitals. We will work with technical and professional personnel to develop protocols for conducting a comprehensive eye examination while focusing on quality of such services as well.

To build a comprehensive eye care system, VISION 2020 – INDIA will:

- Advocating for policy changes that require equitable distribution of eye care services in the society by identifying the underserved districts and focusing on them.
- Developing training programs, in association with medical professionals, which are aimed at developing human resources at all levels in the eye care sector.
- Increasing awareness on issues pertaining to eye health by leveraging the brand ambassador, organizing thematic campaigns.
- Developing strategies to increase the priority given to other eye diseases like low vision e.g. by encouraging member organizations to increase the research done on low priority eye diseases.
- Advocating for integration of eye care in primary health care.

Based on the defined focus areas, VISION 2020 - INDIA developed a five year action plan outlining key activities that need to be undertaken in order to meet our objective of eliminating avoidable blindness by the year 2020. This plan has been developed based on the inputs from strategic plan workshop deliberations of 2011, advocacy roadmap document etc, developed and drafted together by the INGOs (Sightsavers, CBM, OEU, and ORBIS), VISION 2020 - INDIA board members and the Secretariat team. All strategic aspects including e.g. operational research, advocacy, program & policy development, resource mobilization, resource centre and capacity building have been integrated as per VISION 2020: The Right to Sight and WHO Action Plan guidelines.

ADVOCACY

O NISION 2020: The Right to Sight – INDIA is advocacy. VISION 2020 – INDIA represents the collective voice of its member organisations from across the country to voice their concerns to the policy makers at both the Centre and State level. We hold events, workshops, meetings where government representatives are invited and these platforms offer us with an opportunity to influence the government or identify

areas where our efforts can be merged with that of the governments to reach the common goal of eliminating avoidable blindness.

This year we held some important events where government representatives were invited: Madhya Pradesh State plan, Gujarat Diabetic Retinopathy State Plan, Meeting Meghalaya Governor. We also regularly meet senior government officials at the Ministry of Health and Family Welfare (MoHFW) to update them about the activities of our organisation.

One of the main advocacy events organised by VISION 2020 – INDIA annually has been the World Sight Day which has participation from the government.

The World Sight Day is observed globally on the 2nd Thursday of October every year and is a platform to raise awareness about a specific eye disease. The event is held in coordination with the government and has the active participation of the government officials from the Ministry of Health and Family Welfare at the Centre.

In 2011, the WSD was held on October 13 and was organised at Udaipur by VISION 2020 – INDIA's member organisation Alakh Nayan Mandir Eye Institute in association with VISION 2020: The Right to Sight – INDIA and in coordination with National Programme for the Control of Blindness, Ministry of Health and Family Welfare, Government of India.

Usually, the theme for WSD is a common one observed across the world. However, for the year 2011 no common global theme for WSD was announced by the global body. Each country was encouraged to focus on their regional priority area. In India, the theme selected was 'Quality Eye Care'.

Ms. Sujaya Krishnan, Joint Secretary, Ministry of Health & Family Welfare, Government of India; Dr. N.K. Agarwal Deputy Director General, National Blindness Control Programme (NPCB), MoHFW; Yuvraj Mr. Singh Jhala, Educationist and former Principal of B.N. College were the special invitees for the occasion. Several members of VISION 2020: The Right to Sight – INDIA were also present at the event.

To mark the occasion and to raise awareness on the theme of the year, a daylong national symposium on 'Quality Eye Care' was held on October 12, 2011. Eight presentations were made covering a

cross section of topics with a focus on the main theme.

Speaking on the occasion of World Sight Day, Ms. Sujaya Krishnan urged young doctors to serve with zeal to take the mission of eliminating needless blindness towards its goal. She said, "Eyes are not only an important body part but is the most beautiful and cherished gift to us by nature. On this day we pledge to bring light, hope, vision and a new dawn for those who are suffering from avoidable blindness."

Highlighting the importance of the day, Col. (Retd) Dr. Madan Deshpande, President, VISION2020 – INDIA said that each year on this committed day, we make a decision to bring light in the lives of millions of blind people in India who can be cured and this noble verdict of our own makes this day pious. He further added that 80 per cent of blindness can be cured and it is possible only through confidence. Government of India is helping this mission but there is a need to raise the quality of everything we do; quality in treatment and quality in service.

Professor & Head, Community Ophthalmology, Dr. RP Centre, AIIMS gave his valuable input at the workshop. Resource persons participation from the MP state government was in large numbers: Mr. Dilip Kumar Samantaray, Principal Secretary, Health & Family Welfare, Madhya Pradesh; Dr. AN. Mittal, Director, Directorate of Health Services, Madhya Pradesh; Dr. V.A. Joshi, Joint Director& State Programme Officer (NPCB) Directorate of Health Services, Madhya Pradesh; Dr. Dhanila Narayan, Deputy Director (NPCB), Directorate of Health Services, Madhya Pradesh.

Dr. Uday Gajiwala, Medical Director, Divya Jyoti Trust, Surat, Mr. Anand Sudan, SSSN, Chitrakoot, Satna, Representatives, Sightsavers, Representatives, CBM, Representatives, RIO Bhopal and Medical College Indore District Program Managers, Local NGOs were the resource persons. The meeting proved to be successful with active participation from the top and mid level management clinical and non-clinical staff of District Hospitals, DPMs, RIO, Medical Colleges, Mobile Units, NGOs with a total participation of nearly seventy. The objective of the workshop was to identify the gaps in the service delivery of Diabetic Retinopathy – at all levels, HR, infrastructure, governance and prioritising the action plan. 


