VISION 2020: THE RIGHT TO SIGHT- INDIA

VISION 2020: The Right to Sight– India successfully organised the 18th Annual Conference on Community Ophthalmology titled 'VISION 2020 to 2030: Insights and Path Ahead" over three days on 5th – 7th July 2024 at Christian Medical College and Hospital, Ludhiana, Punjab. This year, there were two pre-conferences on 5th July 2024 on "Quality and Accreditation of Eye Hospitals" and "Skill Enhancement for Allied Ophthalmic Personnel". The conference was a significant success, drawing over 600 delegates, including heads of eye care organizations, program managers, ophthalmologists, optometrists, and students from across the country. The diverse participation underscored the importance of the event and highlighted the collective commitment to improving eye health.

Introduction

The recent conference aimed to address eye care issues with a focus on reducing avoidable blindness through collaboration and knowledge-sharing. The broad goal of the conference was to enhance the capacity of the eye care fraternity. The conference also served as a pivotal platform for networking, upgrading technological use, and sharing best practices in eye health.

Objectives

1. Increasing Capacity in Eye Care: The conference sought to build the skills and knowledge of professionals in the eye care field to better address and reduce avoidable blindness.

2. Networking and Knowledge Upgradation: A key goal was to foster networking opportunities among professionals and create an environment conducive to the exchange of knowledge and technological advancements. By connecting various stakeholders, the conference aimed to facilitate the sharing of innovative solutions and practices.

3. Sharing Experiences and Best Practices: The conference provided a platform for sharing successful strategies and experiences in eye health care. This exchange of ideas was intended to enhance planning and implementation of eye care services, ensuring better outcomes and more efficient practices across the hospitals and the institutions.

Key Highlights

Preconference Sessions- 5th July 2024

Preconference Session 1

Quality and Accreditation of Eye Hospitals

Dr. Samina Faiyaz Zamindar, conducted full-day workshop focusing on the quality and accreditation processes within eye hospitals. The session aimed to enhance the understanding and implementation of best practices and standards in eye care facilities. The primary objectives of the workshop were to:

- Develop and refine Standard
 Operating Procedures
 (SOPs), Policies, and
 Protocols.
- Understand and apply Accreditation Standards relevant to eye care.
- Address key areas of Infection Control in eye care settings.
- Review International Patient Safety Guidelines.



- Establish a culture of Adverse Events Reporting.
- Improve patient care practices in surgical environments.
- Promote Continuous Quality Improvement through Key Performance Indicators and Internal Audits.

The workshop featured hands-on activities, interactive discussions, and group exercises to facilitate sharing of experiences and collaborative problem-solving in healthcare quality enhancement.

The workshop successfully met its objectives, equipping participants with valuable knowledge and skills to improve quality and accreditation practices in eye hospitals. Continued efforts and training in these areas are essential



for maintaining high standards of care and patient safety.


Preconference Session- 2

Track 4: Skill enhancement for Allied Ophthalmic Professionals

Allied Ophthalmic Professionals, including optometrists and ophthalmic assistants, are integral to the continuum of eye care from primary to tertiary levels and play a significant role in public health research. To maintain and enhance the quality of eye care services, it is imperative to provide continuous education and skill development. This year's annual conference has focused on various specialized workshops aimed at advancing the skills of these professionals.

The pre-conference workshops successfully provided Allied Ophthalmic Professionals with critical updates

and practical skills in various specialized areas of eye care. By focusing on contact lenses, low vision, pediatric ophthalmology, fundus imaging, and customized ocular prostheses, the workshops have equipped attendees with advanced knowledge and techniques necessary for enhancing patient care and contributing to the broader field of ophthalmology.







Scientific Sessions- 6th and 7th July

The Scientific sessions were spread across four parallel running tracks and a common session with two speakers. All the sessions were designed by the expert scientific committee. The sessions were led by experts in eye care as well as speakers from government sector along with speakers from NGOS who are highly experienced in the field of eye care and community ophthalmology.

Track 1: Synergies and strategies for comprehensive inclusive eye health

In line with the 'Right to Sight,' the central principle of the VISION 2020 program, this track focused on the necessary synergies and strategies to enhance access to high-quality, comprehensive eye care services for everyone, including marginalized groups. Key insights and challenges from the past 20 years of implementing these strategies and outlining future directions were central to this track. Individual speakers and panel discussions addressed the broad themes listed in the box.

Track 2: Quality and sustainability in eye care

The track facilitated dynamic learning, enhancing quality in line with accreditation standards and beyond. To achieve organizational excellence, it's crucial to sustain both human and financial resources while also being mindful of our environmental responsibilities. This track was designed to address the balance between maintaining quality standards and the eye care sector's role in environmental sustainability. This track aimed to inspire hospital management to adopt best practices. The track also included highlights of successful practices developed over the past two decades in both quality improvement and environmental stwardship.

Track 3: Innovate approaches to reach the unreached

This track was focused on innovative ways to achieve Universal Eye Health through Integrated People Centred Eye Care (IPEC) and role of technology. Cost effective approaches of outreach generated with 20 years of implementation experience realizing IPEC principle were the focus in this track. Strategies for Vision 2030 in Sight focussing the unreached was the core of this track. Track 5: Sharing Knowledge Repository: Towards organization's sustainability & growth

Under this track there were free oral presentations based on abstracts reviewed and selected by the Scientific Committee. The speakers were a mixture of presenters from various organisations as well as students. There was a total of 111 paper presentations over two days with broader themes mentioned in the box. There was an extensive response in Poster Presentation as well.

One hundred and eleven abstracts were presented under oral presentation spread over 10 sessions in Day 1 and Day 2 of the conference. The Best of the



Fostering Collaboration: The networking opportunities and collaborative spirit fostered during the conference are expected to lead to continued partnerships and joint efforts in advancing eye health.



Conclusion



Participant's Feedback Report



1. How will you rate the track titled 'Synergies and Strategies for Comprehensive Inclusive Eye Health'?






2. How will you rate the track titled 'Quality and Sustainability in Eye Care'?
